ELECTION OF OFFICERS**

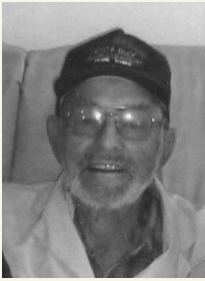

According to the family, he always enjoyed woodworking and after retiring in 1985, created many beautiful objects from various types of wood for his children and grandchildren.

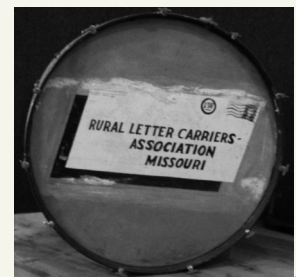

Old Eldon Cemetery

Mike Wieneman, former Eldon resident and early member of the Miller County Historical Society, informed us recently of the existence in the past of an old Eldon cemetery on the west side of town. Here is what he wrote:

Joe,

I never hear or read about anything on the old Eldon City Cemetery that was located on the west side of town. I lived about 1/2 block from it for many years. I can tell you where it was located: Bounded on the South by Second Street. Bounded on the North by First Street.

Bounded on the West by Walnut Street. It did not come as far East as Grand Avenue.

Some of my older relatives remember it as I had family buried there. The present Eldon Cemetery was established in 1895 several years after the founding of Eldon.

A lot of the burials in the old Eldon Cemetery were never removed and sent to the new one. Houses no doubt were built on top of burials there, especially in the oldest part which would be closest to Walnut Street, between First and Second Streets.

My older relatives told me that my great-grandfather's sister Catherine (Clark) Allen is buried here and her daughter Ida is also buried here. They died in 1885. Their bodies were never removed. At one time according to my family, some of the tombstones were used as part of the sidewalk!

Would make an interesting story if you could find out something! If any reader has more information about the old Eldon cemetery we would appreciate it being shared with us!

Thomas J. Babcoke

Methodist Minister Thomas J. Babcoke, was assigned to this area by the Missouri Conference of the Methodist Episcopal Church in 1860. His story is one of great trial as well as adventure because he was one of the major figures serving the northern forces in Miller County during the Civil War. You can read a very detailed and interesting account of his life and the story of his leadership during the Civil War on the archived President's Page of Miller County Historical Society website from September 7, 2009.

The reason I am discussing Babcoke now is that we cannot find a verifiable photo of him. Several descendants of his still live in the area so if any reader knows of one or are themselves a descendent we would certainly appreciate the opportunity to scan for our files an image of Thomas Babcoke, one of Miller County's most notable and historic natives.

Work continued on the probate records throughout the winter. Many people came forward to help with this very important work and we are most appreciative of their assistance.

Of special note is the Americorps volunteers from Eldon, headed by Daphne Partridge. Their willing hands helped put a big dent in the work we had to do in this first phase of preparing the records for microfilming. We were able to get the oldest records out of boxes and into file folders. Staff will be working on the next, more technical step of putting the files in order.

Lynn Morrow, John Korasick, and Dianne McKin-

ney of the Missouri State Archives have given their professional support and guidance to this very important project.

Four new file cabinets were purchased to hold the records. This will allow the documents to "relax" and protect them from further damage until they can be microfilmed.

Next winter we hope to tackle flattening the balance of the records. It doesn't seem there is any end in sight, but progress is definitely being made. So for those of you who missed this "fun" activity this winter, there is always next year.
