WALDO SHERRIL STEEN LEGACY

In the fall of 2009, Waldo Sherril Steen and his wife of 60 years, Alice Faye (Pemberton), very generously designated the Miller County Historical Society as the beneficiary of his IRA. The annual required minimum distribution (RMD) from Sherril IRA went directly to MCHS each January and helped to pay the museum fixed expenses. Since Sherril death in June, the necessary paperwork has been completed to facilitate the transfer of those funds from his IRA to the Historical Society.

Central Trust and Investment Company has been chosen to manage those assets using a balanced growth approach. Trenny Garrett, J.D., CTFA, Sr. Vice-President, and William Max, Vice-President, Portfolio Manager, met with the MCHS board members on November 18 and gave a very detailed presentation of their investment plan. The annual distribution to the museum will continue, but the account will be safeguarded so it will remain in perpetuity.

All of us who work with the Miller County Historical Society want to once again thank the Waldo Sherril Steen family for this amazing gift. Sherril and Alice hoped to encourage others by setting an example of generous living and they certainly did!


- Missouri State Archives has completed microfilming the probate records and they will soon be back in our files.
